THIS FIFTH AMENDMENT TO AMENDED AND RESTATED MASTER DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR SKYE RANCH ("Fifth Amendment") is made this 4th day of October, 2021, by TAYLOR MORRISON OF FLORIDA, INC., a Florida corporation ("Master Declarant").

Notwithstanding Sections 19.1 and 19.2, any amendment to this Master Declaration that alters any provision relating to the Surface Water and Storm Water Management System, beyond maintenance in its original condition, including the water management portions of the Master Association Property, or amendment to this Section 19.3, must have the prior approval of the SWFWMD and the prior written approval of the County Engineer or his authorized designee.

- 5. Except as modified hereby, the Master Declaration shall remain in full force and effect in accordance with the terms thereof.
